



Center ISD Student Charge Policy

Students will be allowed to charge up to \$20.00. Any student with charges at or over \$20.00 will receive an alternate reimbursable meal in place of the scheduled entrée. This can be avoided by making payments to the students account through cash or check at the register or at the Food Service office or online at www.myschoolbucks.com.

On May 1st of every school year, no student will be allowed to charge any meal to their account. All students that do not have funds to pay for their meal will receive an alternate reimbursable meal.

All students/guardians, regardless of the student's eligibility, are responsible for all charges made to the student's account. Payment can be made at the register or at the Food Service office by cash or check made payable to Center ISD. Payments can also be made by credit/debit cards online at www.myschoolbucks.com.

PREPAYMENTS

May be made at your student's cafeteria by cash or check. Payments can also be made at the Food Service office at 404 Mosby Street or online at www.myschoolbucks.com.
