Center High School Parental Involvement Policy

Statement of Purpose

Center High School is committed to the goal of providing the highest quality education to prepare our students for academic, emotional, and social success. We want to establish a strong commitment to partnerships with parents and with the community. Everyone gains if school and home work together to promote high achievement for our children. Parents play an extremely important role as the child's first teacher. Parental involvement with your child and school is critical to a student's success every step along the way. We recognize that some students may need the extra assistance available through the Title I Program to reach grade level goals. Center High School intends to include parents in all aspects of the Title I Program. The goal is that the school-home partnership will help all students in our school succeed.

Parental Involvement in Developing the Policy

Title I regulations require that each school served under Title I jointly develop with and distribute to parents of participating children, a written parental involvement policy agreed on by the parents that describes the requirements outlined in Title I law.

Parents, members of the community, and school staff will meet to discuss the implementation of the parental involvement policy. Center High School will hold meetings for parents during each school year. A meeting will be held by the end of October to specifically review with parents Title I School requirements and the school's Parent Involvement Policy. Parents will be informed of Title I guidelines and the variations from the previous year's program. Copies of the current campus parent involvement policy will be distributed. Parents will be encouraged to become involved in revising and updating the policy as deemed necessary. We will use the results of the evaluation of parent surveys in determining strategies for school improvement in revising the parental involvement policy at the campus level. The meetings will be held at convenient times and locations as agreed upon by all concerned parties. Translation for Spanish speaking parents will be made available upon request. Participation will be encouraged through notification by ads in local media and emails as well as letters sent home.

Parents are invited to participate in a variety of meetings and activities over the course of the school year. An Open House will be held each semester to provide parents the opportunity to formally visit their child's classroom to become better informed about grade level expectations and their student's academic progress. The school also hosts parent/teacher conferences that can be flexibly scheduled to accommodate the parent's work schedule and encourages parental involvement on the LPAC committee and the Campus and District Improvement Committees.

Parents are invited to the school's Veteran's Day program, performances at community events, book fairs, a Thanksgiving meal, multiple music and holiday programs, awards ceremonies, and to accompany their student on a variety of athletic events.

Due to the varying schedules of all members of our community, efforts will be made to provide as much information as possible on the school and district websites so that parents can access it twenty-four hours a day. Additionally, the school utilizes social media, teachers use the Remind App, and all students have Google Classroom that parents can access for summarized classroom information.

Involve parents, in an organized, ongoing, and timely way in the planning, review, and improvement of programs under this part, including planning, review, and improvement of the school parental involvement policy;

Our school annually invites parents to participate in review and revision meetings to examine and discuss our Campus Improvement Plan and Parental Involvement Policy.

We use a variety of communicative techniques to solicit parent participation and deliver important information in hopes of creating productive dialogue between home and school concerning improved student achievement. Share Responsibilities for High Student Academic Achievement

Due to the amount of paper that is sent each year from school to home, written information is purposefully as compact and concise as possible. Center High School has made it a practice to translate specific information into Spanish to ensure all information related to our school is understandable. Office staff fluent in Spanish is always available to share information with parents and to answer questions in their home language, translators are available upon request for meetings and conferences, and written communication is translated to the extent possible.
